# GETACTIVE! SINGAPORE 2022 NURTURE KIDS CAMPAIGN

## **Terms and Conditions**

BY PARTICIPATING IN THIS CONTEST, YOU HEREBY CONFIRM THAT YOU HAVE READ, UNDERSTOOD AND AGREED TO BE BOUND BY THE FOLLOWING TERMS AND CONDITIONS ("TERMS").

### 1. The Organiser

1.1 The contest under the GetActive! Singapore 2022 Nurture Kids Campaign (the "Contest") is organized by the Singapore Sports Council (rebranded as 'Sport Singapore' with effect from 1 April 2014 and hereinafter referred to as "SportSG") of 3 Stadium Drive, Singapore 397630.

#### 2. Duration of Contest

2.1 The Contest starts on 1 June 2022 and will end on 30 June 2022 (the "Contest Period"). The deadline for submission of all Entries is 30 June 2022, 2359hrs Singapore time (GMT +0800).

## 3. Eligibility

- 3.1 The Contest is open to Participants who fall under any of the categories below:
  - **Category 1**: Preschools and Early Intervention Centres registered in Singapore. **Category 2**: Singapore Citizens, Singapore Permanent Residents and foreigners residing in Singapore
- 3.2 Participants who are below 18 years of age must submit proof of parental or guardian consent for participating in the Contest, when required by SportSG.
- 3.3 Officers or employees of SportSG (as well as their immediate family members), contest administrators and anyone professionally connected with this Contest shall not be eligible to participate in this Contest.
- 3.4 The Participant's Entry must be received by SportSG during the Contest Period to be eligible. Proof of submission does not constitute proof of receipt of the Entry. SportSG accepts no responsibility for any late, lost or misdirected Entries, including Entries not received by SportSG or delays in the delivery of the Entries due to technical disruptions, network congestion, server failure or any other reason.

## 4. How to Participate

- 4.1 Participants can submit their Entry for the Contest by filling out the form and uploading their video submission at <a href="http://circle.myactivesg.com/getactive-singapore/nurture-kids/challenge">http://circle.myactivesg.com/getactive-singapore/nurture-kids/challenge</a>.
- 4.2 Each Participant may submit multiple entries for the Contest but will only be eligible to receive one prize.
- 4.3 The Entry must be the Participant's own original work.

#### 5. Entry Terms and Conditions

- 5.1 By taking part in this Contest, each Participant represents, warrants, undertakes, agrees and/or acknowledges that:
  - 5.1.1 the information, details and particulars submitted by the Participant to SportSG are true, accurate and complete. Any incomplete Entry (including failure to furnish any required details) may be disqualified from the Contest at SportSG's sole and absolute discretion;
  - 5.1.2 the Participant's Entry is the Participant's own original work, the Participant is the sole legal and beneficial owner of all intellectual property rights to the Participant's Entry, and the Entry does not infringe on any copyright or other proprietary right of any third party;
  - 5.1.3 the Participant grants to SportSG an irrevocable, royalty-free licence to reproduce and use the Participant's Entry for publicity and communications purposes related to the Contest and/or SportSG across all media, including, without limitation, in SportSG's publications, presentations, promotional materials and on its websites, and for the purposes set out in Clause 6.3;
  - 5.1.4 in respect of any third party's personal data that may be collected, used and/or disclosed by the Participant in the Entry and pursuant to these Terms, the Participant warrants that the relevant consents have been obtained from such third party for such collection, use or disclosure in compliance with the Personal Data Protection Act 2012:
  - 5.1.5 the Participant's Entry does not defame, abuse, harass, stalk, threaten or otherwise violate the legal rights (such as rights of privacy) of others;
  - 5.1.6 the Participant's Entry is not obscene, pornographic, sexual, indecent, excessively violent or otherwise inappropriate, and does not contain unlawful material or information:
  - 5.1.7 the Participant has read and understood, and thereby agrees to all Terms as set out herein, including all amendments, additions, replacements and modifications hereto as may from time to time be made by SportSG; and
  - 5.1.8 if the Participant is under the age of 18, the Participant has obtained the consent of the Participant's parent and/or guardian to take part in the Contest, and in such instance any references to consent in these Terms shall refer to consent from the Participant's parent/guardian.
- 5.2 SportSG reserves the right, at its sole and absolute discretion, not to consider and to exclude or disqualify any Entry, or to forfeit, withhold, withdraw or reclaim any prizes already awarded, where (1) the Participant is deemed to be acting in violation of these Terms or abusing or tampering with the operation of these Terms; (2) the Entry which a Participant has submitted contains false or incomplete information; or (3) there are other reasons that SportSG considers at its sole discretion an Entry has been made in any manner inconsistent with these Terms or for the Contest. In any such event, no explanation shall be provided by SportSG and no appeals in relation to such decision by SportSG shall be entertained.
- 5.3 By entering this Contest or accepting a Prize, the Participant agrees to indemnify, release and hold harmless SportSG's directors, officers, employees and representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant taking part in the Contest, breaching these Terms or accepting any Prize, including without limitation, personal injuries, death and property damage. All warranty claims in relation to a Prize should be directed to the

applicable merchant. Except to the extent that they may not be excluded by law, no representations, warranties, terms or conditions that are not expressly stated in these Terms apply to this Contest nor in respect of the Prizes and all implied warranties are excluded, including but not limited to, the implied warranties of satisfactory quality, merchantability or fitness for a particular purpose of any of the Prizes.

#### 6. Prizes and Prize Collection

- 6.1 Thirty (30) winners from Category 1 and ten (10) winners from Category 2 shall be selected by a panel determined by SportSG.
- 6.2 All Prize winners shall receive vouchers which can be used for the purchase of sporting equipment. The participating merchant(s) will be announced on the ActiveSG Circle website before the Contest Period. The following Prizes shall be awarded:
  - Category 1: Participants who submit the best 10 Entries shall be awarded a **\$\$500** voucher each, while participants who submit the next best 20 Entries shall be awarded a **\$\$250** voucher each.
  - **Category 2**: Participants who submit the best 10 Entries shall be awarded a **\$\$100** voucher each.
- 6.3 Participants whose Entries are selected as the top 57 Entries across both categories shall have their Entries adapted into resources for compilation into a multi-game catalogue to commemorate National Day 2022.
- 6.4 All winners will be announced on the ActiveSG Circle website after the end of the Contest Period. SportSG shall notify all Prize winners via their contact details as furnished in their Entry submission, and such notification will include instructions on prize collection. SportSG shall not be liable for late, lost, misdirected or unsuccessful efforts to contact and notify the winners.
- 6.5 Prizes are not negotiable, transferable, exchangeable or redeemable for cash, credit or kind, either in part or in full. Prizes must be taken as stated and no compensation is payable if a winner is unable to use a Prize as stated. There is no refund for a partially used Prize. SportSG reserves the right at any time and at its sole and absolute discretion to substitute, withdraw or cancel any Prize or make changes to the value and/or number of the Prizes at any time without prior notice and without having to disclose any reason therefore and without any payment or compensation whatsoever in lieu thereof.
- 6.6 SportSG reserves the right, at its sole and absolute discretion, to substitute any winner and to determine if there will be no, or fewer, winners for the Contest.
- 6.7 SportSG will not be responsible for any consequences that any Participant may suffer (including without limitation any damage, loss, injury or disappointment), or that may result in infringement of any law or regulation, by entering the Contest or accepting any Prize. SportSG accepts no responsibility for any tax implications that may arise from accepting a Prize.
- 6.8 Proof of identity must be provided at the point of prize collection. No right to compensation shall accrue nor be given to the winner if he/she fails to provide proof

- of identity as well as any relevant documents or information to SportSG at the point of collection or fails to claim the prize in accordance with the collection instructions provided by SportSG.
- 6.9 By accepting a Prize, the winner signifies his/her agreement and consent to participate in and to co-operate as may be required by SportSG with all reasonable media requests relating to the Prize, including but not limited to, being interviewed, photographed and having his/her name, photo and quotes published by SportSG on any of its channels and platforms for publicity purposes and communications related to the Contest. If the winner withdraws his/her consent, he/she shall surrender the Prize to SportSG. For the avoidance of doubt, such consent may not be withdrawn after any part of the Prize is used by the winner.

# 7. Information of Participants

- 7.1 SportSG shall use personal information of the Participants in accordance with the Personal Data Protection Act 2012 and SportSG's Privacy Statement (<a href="https://www.sportsingapore.gov.sg/Privacy-Statement/">https://www.sportsingapore.gov.sg/Privacy-Statement/</a>).
- 7.2 By participating in the Contest, the Participant agrees that any and all personal data submitted may be collected, used and/or disclosed by SportSG for various purposes, including to communicate with the Participant for purposes related to the Contest, and such other purposes that SportSG may reasonably deem appropriate. SportSG may collect, use, disclose and share the Participant's personal data with its related bodies, corporations and agencies assisting with the Contest, including the Participant's photographs or audio-video or other recordings for publicity and/or use in advertisements across all media, including, without limitation, in SportSG's publications, presentations, promotional materials on its websites without further notification, remuneration or compensation.

# 8. Miscellaneous

- 8.1 Notwithstanding anything in these Terms, SportSG reserves the right at any time and in its sole and absolute discretion to cancel the Contest or amend the Terms without prior notice, including but not limited to the Terms concerning the eligibility for the Contest, criteria for the Contest and the selection of winners.
- 8.2 SportSG's decisions in all matters related to the Contest shall be final and binding.
- 8.3 In the event of any inconsistency between these Terms and any brochures, marketing or other promotional materials or communications relating to the Contest, these Terms shall prevail.
- 8.4 The Contest and these Terms shall be governed by and construed in accordance with the laws of Singapore, and by participating, the Participant submits to the exclusive jurisdiction of the Courts of the Republic of Singapore.
